Dear Property Owner:

In the near future Asplundh Tree Expert Company will be performing vegetation maintenance on the PPL Electric Utilities transmission line right of way on your property.

Trees and other tall vegetation must be kept away from power lines. If they get too close, the result can be a serious power outage. There also is the potential for a significant safety risk to you, and to our employees.

The work we will perform may include removals of incompatible trees and other vegetation, hand or mechanical brush clearing and other possible activities.

In wooded and other non-urban areas, we mow and/or hand-cut all vegetation on the full width of the right-of-way. This includes any larger brush, trees and all woody stems within the width and length of PPL right away.

Soon after the mechanical work is completed, herbicide treatment will be applied to prevent the rapid regrowth of woody species and to promote a future meadow-like appearance. All herbicides will be applied selectively, are approved by the U.S. Environmental Protection Agency, and will be applied by personnel certified by the Pennsylvania Department of Agriculture. The application will be completed this year with ground equipment or on foot as the weather permits. NOTE: Lawn areas, garden plots, farm land and animal pastures are generally *not* treated.

On properties with yards on the PPL right-of-way, we will be clearing the wire zone of woody-stem plants and will leave compatible species in the border zone wherever possible. Incompatible species in the easement will need to be removed. In addition, "danger trees" located outside the given clearing widths which present a hazard to the line will be evaluated and cut as may be necessary.

This work is part of PPL Electric Utilities' ongoing vegetation management program to ensure safe reliable electric service. It will be performed at no cost to the property owner.

We recognize that some property owners may be concerned about vegetation removal, particularly because these species have been allowed to remain in the past. We are committed to answering your questions and discussing your concerns while still accomplishing the vegetation management work that is necessary to protect you and your neighbors throughout the region from serious power outages.

In all cases where we perform vegetation management work, we have the specific right to do so as provided in written right-of-way agreements PPL has for each property. The work is scheduled to start on or after October 17, 2012, weather permitting.
